8. Description of Project (Describe the whole action involved, including but not limited to, later phases of the project, and any secondary, support, or off-site features necessary for its implementation. Attach additional sheets if necessary):

A group of citizens from the second half of the unincorporated community of Panorama Heights, a community located in North Tustin, ("Petitioner") want to transfer inhabited territory from the Orange Unified School District ("OUSD") to the Tustin Unified School District ("TUSD").

According to the petition submitted to the Orange County Superintendent of Schools for consideration by the Orange County Committee on School District Organization ("County Committee"), the area to be transferred consists of 459 residences and empty lots in Panorama Heights. The Petitioners stated the request for changing the boundaries of the school districts was based on Unification of North Tustin

Community and the petition meets the Nine Criteria To Change School Districts Per Education Code Section 35753.

The “project” involves only the environmental consequences of changing the school boundaries as described previously and in the petition. Under the current boundary alignment, current (and future) students within the transfer area attends OUSD schools and under the proposed transfer of territory, they would attend TUSD schools. The project does not involve the acquisition of real property or the construction of any physical improvements. Zoning and general plan designations are not applicable to the project.

9. Surrounding Land Uses and Setting (Briefly describe the project’s surroundings):

The petition area is currently located within the jurisdiction of the OUSD. The OUSD serves approximately 28,522 students in 38 school sites in grades kindergarten through 12th, and encompasses all or part of the cities of Anaheim, Garden Grove, Orange, Santa Ana, and Villa Park.

The TUSD, located south of the petition area, serves approximately 24,130 students in 29 school sites in grades kindergarten through 12th, and encompasses all or part of the cities of Tustin, Santa Ana, and Irvine.

10. Other Public Agencies Whose Approval Is Required (e.g., permits, financing approval, or participation agreement):

The Orange County Committee on School District Organization (“County Committee”) has the primary approval authority over the proposed petition and, as such, is the Lead Agency under the California Environmental Quality Act (CEQA). This review evaluates only the potential environmental impacts of this transfer of territory, which would have the effect of shifting the schools attended by the students living within the transfer area from schools located in OUSD to schools located in TUSD.

Education Code Section 35753(a) establishes the criteria to be used by the County Committee in making its decision on the appropriateness of this petition. These criteria are outside the purview of CEQA and will not be addressed in this study.

This review has been prepared in accordance with CEQA Guidelines to determine if the transfer of territory could have a significant impact on the environment. This analysis will provide the County Committee with information to document the potential impacts of the proposed transfer and determine whether to prepare an Environmental Impact Report (EIR), a Negative Declaration, or a Negative Declaration with mitigation measures.

The Committee will hold public hearings in both OUSD and TUSD on September 6, 2017 pursuant to Education Code Section 35705 and 35705.5. All documents are available for viewing and/or downloading on the Committee’s website at <http://www.ocde.us/CCSDO/Pages/default.aspx>.

PETITION FOR TRANSFER OF TERRITORY

To the Superintendent of Schools of Orange County:

Pursuant to *Education Code* 35700, Subdivision (a), the undersigned, constituting at least 25 percent (25%) of the registered electors residing in the territory proposed to be transferred that is currently in the Orange Unified School District, petition that the boundaries of the Orange Unified School District be changed to eliminate from the Orange Unified School District (OUSD) the territory hereinafter described. The undersigned persons petition that the described territory be transferred to and included within the Tustin Unified School District (TUSD).

The property to be transferred is described as follows:

The property to be transferred is described as follows: The second half of the unincorporated community of Panorama Heights in North Tustin 92705. Comprised of 459 residences and empty lots, which includes the following streets: 12321-12371 Alexander Lane, 12255-12312 Alta Panorama, 12817-18957 Artnell Rd, 12132-12662 Baja Panorama, 12471-12561 Barrett Lane, 18772 -18832 Barry Lane, 19251-19302 Brae Glen, 12502-12562 Carmel Way, 12672-12772 Charmaine Lane, 12219-12591 Circula Panorama, 12821-12861 Craftsman Lane, 10261-10401 Crawford Canyon Rd, 10385-19322 Cresthaven Lane, 18741-18921 Fairhaven Ave, 12801-19321 Fairhaven Ext, 18822-19151 Fowler Ave, 12812-12952 Hewes Ave, 12562-12652 Kingsview Rd, 19291-19361 Maynard Way, 12272 -12312 Media Panorama, 12262-12311 Menuda Panorama, 12722-12762 Mittman Lane, 12831-12962 Old Foothill Blvd, 18861-18902 Parkview Terrace, 19291-19356 Saylor Terrace, 19181 Stoller Ln, 12251-12696 Vista Panorama, 18751-18835 Winnwood Lane. The undersigned request the changes in the respective boundaries of the school districts for the following reasons:

1. Unification of North Tustin Community

- a. The entire neighborhood is situated in the boundaries covered by the North Tustin Advisory Council and the Foothill Community Association, the local political advisory groups that protect the rights and interests of "North Tustin" residents in 4,600 acres of Orange County unincorporated area.
- b. Current petition includes all of the other half of Panorama Heights and surrounding 'Lower Panorama' neighborhoods in North Tustin to avoid creating 'islands'.
- c. Other half of Panorama Heights is currently zoned for TUSD, current omission of second half of Panorama Heights creates an arbitrary division of the neighborhood.
- d. Many children already attend TUSD schools as OUSD allows inter-district transfers to TUSD upon request. Note though that inter-district transfer permits are granted year-to-year depending on enrollment and are not guaranteed for continuing students.
- e. The primary faith, sports, activity organizations in which children of Panorama Heights participate are based in Tustin, CA.
- f. Following suit after another North Tustin area, Rocking Horse Ridge II's successful petition approval to transfer territory from the OUSD to the TUSD in 2012.

2. The petition meets the Nine Criteria To Change School Districts Per Education Code Section 35753 as follows:

- a. **Criteria #1:** The reorganized districts will meet the adequate enrollment condition. Less than 5% of Panorama Heights residents utilize the OUSD.
- b. **Criteria #2:** The school districts are each organized on the basis of a substantial community identity. Panorama Heights residents identify with the Tustin community through sports, community events, and commerce.
- c. **Criteria #3:** The transfer of territory will result in an equitable division of property and facilities of the original districts. The transfer of the small percentage of students that currently attend OUSD schools will not require any division of property and facilities within the district.
- d. **Criteria #4:** The transfer of territory will not promote racial or ethnic discrimination or segregation is substantially met. The current Panorama Heights students are less than 1% of the OUSD current enrollment. Statistically, these numbers are insignificant, and will have no effect on demographic composition of either school district.
- e. **Criteria #5:** The transfer of territory will not result in any substantial increase in costs to the state. The unification of Panorama Heights into the rest of North Tustin community school boundaries will have no costs to the state.
- f. **Criteria #6:** The transfer of territory will not significantly disrupt the educational programs in the school districts and the school districts affected by the transfer of territory will continue sound educational performance is substantially met. The current Panorama Heights students are less than 1% of the OUSD current enrollment. Statistically, these numbers are insignificant, and will have no effect on educational programs of either school district.
- g. **Criteria #7:** The transfer of territory will not result in a significant increase in school facilities costs is substantially met. The transfer will require no new facilities costs.
- h. **Criteria #8:** The transfer of territory is not primarily designed to result in a significant increase in property values. The purpose of the transfer is to unify the North Tustin neighborhood, such that Panorama Heights children go to the same schools as their community of influence.
- i. **Criteria #9:** The transfer of territory will not negatively affect the fiscal management or fiscal status of either school district affected by the transfer of territory. The current Panorama Heights students are less than 1% of the OUSD current enrollment. Statistically, these numbers are insignificant, and will have no effect on fiscal status of either school district.

Area of Election:

In the event that the County Committee approves the transfer, but Orange Unified School District does not consent to the transfer, we, the petitioners, believe the election area should be limited to the Panorama Heights Community.

Bond Disclosure:

Over the past decade, voters living within TUSD have approved two bond measures that benefit TUSD, Bond Measure G and Bond Measure L. These bonds help to pay for upgrades to campuses within TUSD and to improve technology in the classrooms. The bond assessments are included with property taxes for TUSD residences, and are approximately \$60 per \$100,000 of assessed property value. As of November 2016, OUSD's Bond Measure S was approved, they are included in property taxes for OUSD residences, affording the district \$288 million.

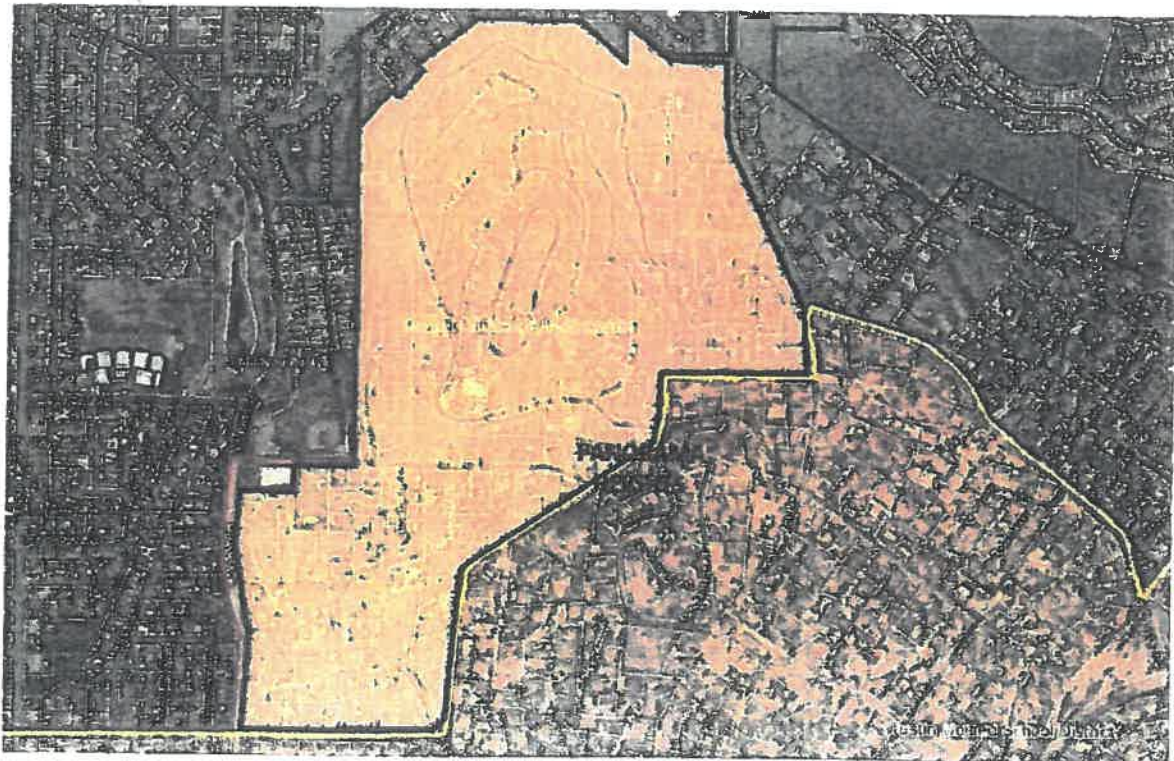

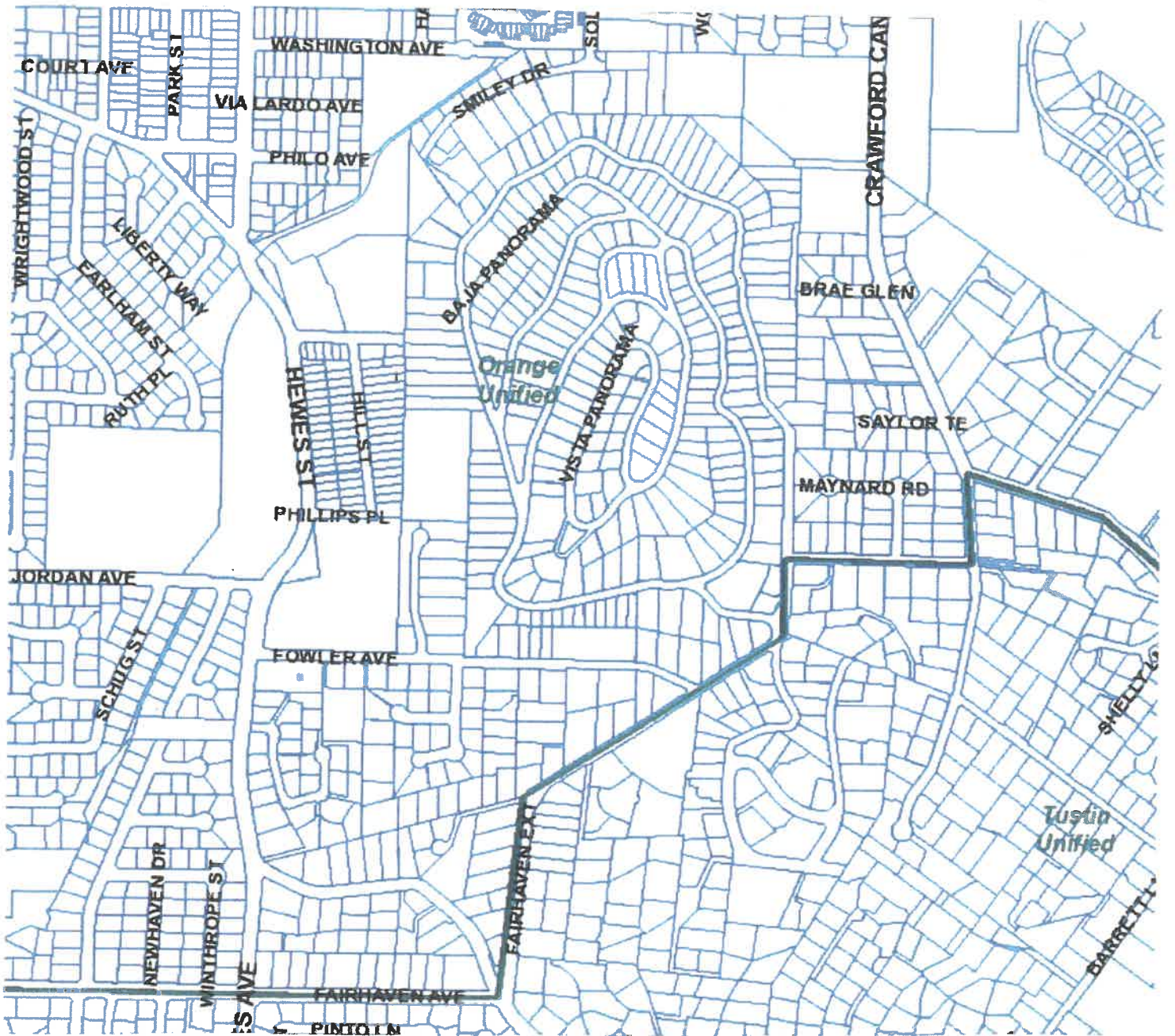

Pursuant to the procedures of the Orange County Committee on School District Organization ("County Committee") for the implementation of the California Environmental Quality Act, the County Committee has completed an environmental review for the project described below:

Project Information:

Project: Panorama Heights II Transfer of Territory

Project Location: The petition area is the second half of the unincorporated community of Panorama Heights, located in North Tustin, CA that currently falls under the jurisdiction of the Orange Unified School District (OUSD). The OUSD serves approximately 28,522 students in 38 school sites in grades kindergarten through 12th, and encompasses all or part of the cities of Anaheim, Garden Grove, Orange, Santa Ana, and Villa Park.

Project Lead Agency: Orange County Committee in School District Organization

Project Description: A group of citizens from the second half of the unincorporated community of Panorama Heights located in North Tustin, California ("Petitioner") has petitioned the County Committee to transfer inhabited territory from the Orange Unified School District (OUSD) to the Tustin Unified School District (TUSD).

The petition area is currently located within the jurisdiction of the Orange Unified School District. The OUSD serves approximately 28,522 students in 38 school sites in grades kindergarten through 12th, and encompasses all or part of the cities of Anaheim, Garden Grove, Orange, Santa Ana, and Villa Park. The Tustin Unified School District, located adjacent to the petition area, serves approximately 24,130 students in 29 school sites in grades kindergarten through 12th, and encompasses all or part of the cities of Tustin, Santa Ana, and Irvine.

The "project" as defined for this environmental review involves only the environmental consequences of changing the school boundary as described above. Under the current boundary alignment, students within the transfer area attend OUSD schools and under the proposed modification, they would attend TUSD schools.

Existing Conditions: The current district boundary line requires students living in the transfer area to attend schools in OUSD.

Summary of Impacts: Attached are the Environmental Checklist and a copy of the transfer of territory petition.
